SECTION D: CANCELLATION & REFUND POLICY

- 1) The Application / Registration Fees is Non Refundable.
2) **Except** in case of provider default or student visa / study visa refusal will only be made in the following circumstances,

a) Where you withdraw from the course AFTER the course start Date

if a written notice is received not less than 14 days prior to the Course start Date, the Centre, will within 28 days refund the course fee less the cancellation fee, No refund of fees will be given where notice is received after 14 days prior to the course start date including where the course starts date passed,

b) Where you withdraw from the course AFTER Course start Date

No refund of fees will be given once the course starts Date has passed. Once you start the Course you may withdraw from a course after week 1 of the course current term / week, and you must pay withdraw fee.

Provider default

3) In case of provider default, that is where the Centre cancels or stop providing you Services for any reason, the Centre will within 14 Days refund on a pro rata basis the Course fee for the week that the Centre will not be provided Unless:

- (i) you withdraw from the course before it is canceled: or
